

The Value of DICOM Membership

The Digital Imaging and Communications in Medicine, or DICOM, has been the foundation of the medical imaging world over the last three decades, facilitating interoperability between medical imaging systems from various vendors, allowing seamless sharing and exchange of medical images and related patient information across healthcare facilities, ultimately improving patient care. DICOM is updated multiple times each year to support the steady stream of new medical imaging technologies and emerging applications.

Being a member of the DICOM Standards Committee (DSC) allows your organization to participate directly in the development and maintenance of the parts of the Standard that most affect you. You can put forward new needs, gaps, or issues detected during product development and deployment, contribute to corresponding revisions or extensions to the Standard, monitor and get early access to draft text, participate in voting, and have your staff gain expertise in the Standard and develop a deeper understanding of the dataflows and integrations that it supports by participating in the consensus building discussions.

The contributions by your organization and people are an investment in the future of healthcare innovation and patient care. Through DICOM membership, stakeholders empower the medical community to advance diagnostic precision, streamline care delivery, and ultimately improve lives.

DICOM Dues Structure

As the Secretariat, NEMA develops the dues structure for DICOM in consultation with the DSC. This dues structure will be in place for 2026. This structure is tiered based on medical imaging revenue to match the DICOM funding that MITA vendors provided previously through MITA. An additional category exists for companies who are not in the medical imaging space but have a stake in the critical work of DICOM. The structure is intended to equitably fund DICOM activities, in that smaller organizations are asked to pay a smaller share, and larger organizations are asked to pay a correspondingly larger share.

Note: DICOM participants will not be considered nor characterized as NEMA members unless they choose to join NEMA separately.

Companies are asked to self-certify to their dues category once membership is approved by the DICOM Standards Committee; NEMA does not intend to collect financial information from companies to confirm revenue information.

DICOM Membership Application

Membership in the DICOM Standards Committee (DSC) is available only to manufacturers, vendors, consulting companies, biomedical professional societies, trade associations, government agencies, and standards-development organizations -- but not to individuals. Voting Members of the DSC approve new supplements and revisions to the DICOM Standard that are developed and recommended by DICOM Working Groups.
